Community Meeting March 22, 2017



July 2007: Bethany Branch opens in in Bethany Village

- 1,800 square foot storefront
- Cost = \$65,000
- Expansion funded by CMCLA fundraising efforts
- Tenant improvements done by volunteers
- Furnished with donated shelving and furniture
- 6,252 items
 - Collection grows to 20,952 by June 2008
- 4 Staff (2 Full Time/2 Part-Time)









July 2009: Bethany Branch moves across the street due to incredibly high levels of library use

- 4,641 square feet of space
- Cost = \$122,000
- Expansion funded by CMCLA fundraising efforts
- Volunteers and staff move all books, shelving, furniture and technology across the street
- 31,010 items
- 13 staff (5 Full Time, 8 Part-Time)



- Bethany Branch outgrows new space within one year.
 - Collection grows to 42,656 items by July 2010
- 2010 2013: CMCLA investigates expansion options.









- 2011: Central Bethany submits site development plans for the Plaza at Bethany Village.
 - Five multistory buildings
 - 90,000 square feet of retail, restaurants, office and residential space
 - Plaza level parking for 112 cars, plus 270 spaces below the plaza





- 2013: CMCLA signs a letter of intent to lease 10,000 square feet of space in Plaza at Bethany Village
 - Dependent on lease terms and library's ability to secure funding.
- 2016: The library hires FFA Architects to prepare renderings and cost estimates for new library in Bethany Plaza.
- Construction schedule has not been determined but may begin in 2018, with library space ready by 2020.

- Six BSD Elementary Schools
 - Represents 22% of elementary school enrollment
- One Middle School

- Sato Elementary School scheduled to open in Fall 2017 (will serve up to 750 students)



STAFF & VOLUNTEERS

- February 2017
 - 9.56 Full Time Equivalent (FTE) Staff
 - 4 Full Time, 13 Part-Time
 - 35 Active Volunteers
 - 218 hours/month = 1.36 FTE







CURRENT CHALLENGES



- Lack of Meeting Room
 - Limits programs we can offer during open hours.
 - Patrons have requested a meeting room for groups to use.

Space

- Limited space for patrons to sit and read or meet with groups.
- During the summers, families spread out on the floor in the children's area when all the tables were full.
- Limited space for patrons who bring in laptops and need an electrical outlet.



CURRENT CHALLENGES



Parking

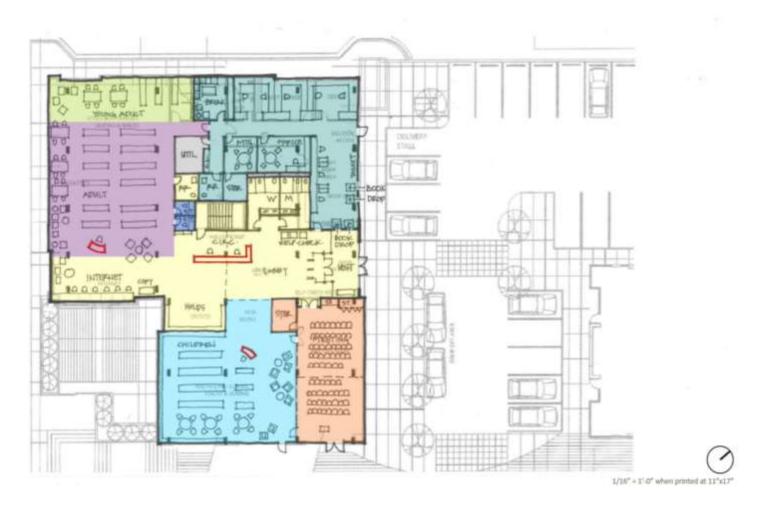
- Lack of drive up book drop and 5 minute parking makes it difficult for patrons to return materials.
- Due to lack of parking, many patrons double park on Central Drive during busy traffic periods.

Materials

- No room for larger collections and more selection
- Not able to expand high demand collections
 - Children's materials, Bestseller books and media, World Languages
- Not able to add any collections

PROPOSED LIBRARY



- 10,000 square feet of space
 - Includes multipurpose room for classes and programs
 - More space for books, magazines and media
 - More seating for readers
 - More computer stations
 - Easily accessible book return
 - Defined space for teens and more separation between children and adult users
- Project Budget \$2 Million
 - Includes design, build out, tenant improvements, furniture, shelving, computers and equipment
 - Does not include additional leasing and operational costs



PROPOSED LIBRARY -Benefits



Space

- Meeting space for community groups
- Space for displaying and housing community information
- Library seating increases to 68 (plus another 70 in the meeting room), compared to 21 in current space.
- Better parking for cars and bikes

Materials

- 20% increase in shelf space will allow for development and promotion of many high interest areas that cannot be housed in current space.
- Non-English collections will have more space



PROPOSED LIBRARY -Benefits



Services and Programs

- Children's and teen programs can be held inside the library.
 - In current space, many programs are held offsite or after hours.
- Expansion of storytime programs to include ALL developmentally appropriate ages
 - Babies, One Year Olds, Toddlers and Preschoolers
- Storytimes in other languages
- Adult Programs
 - Additional space and staff will allow more adult oriented programs to be offered.

Technology

- Internet stations will increase by 50%.
- More seating and outlets to access wireless technology.



FUNDING



- Bethany and Cedar Mill Libraries are located outside of city boundaries in unincorporated Washington County.
 - No public funding available for library buildings in our area
 - Funding from Washington County is for library operations only.
 - CMCLA receives 83% of funding from WCCLS; remaining 17% must be made up through fundraising – individual donations, 2nd Edition Resale, grants
- \$2 Million+ needed for the Bethany Library expansion is dependent on private support from the community.
- This will be one of the biggest projects ever taken on by the growing Bethany community.
